Ing. Štefan Máj

Chairman of the Board of Directors and the CEO of Slovenská sporiteľňa

He has been working in Slovenská sporiteľňa since 1991, first as the head of Property Management Unit, then as the general director of the Technology Division, and later as a board member. From 1995 to 1998 he worked at several positions in Komerční banka Bratislava. In December 1998 he came back to Slovenská sporiteľňa. He contributed significantly to restructuring and the process of privatisation of the bank. Since 1 January 2015 he has been the Chairman of the Board of Directors and the CEO of Slovenská sporiteľňa, while being responsible for finances and staff units.

As the CEO of Slovenská sporiteľňa he has contributed to its positive economic results, which in 2016 helped the bank win the Trend Top Bank of the Year Award for the fifth time in a row. Štefan Máj is also a double Banker of the Year and a laureate of Krištáľové krídlo Award in the category Economy. Apart from banking, he likes sports; he is currently the Slovak champion in orienteering in the age category 60-64.



Prof. Ľuboš Pástor, PhD.

Member of the Bank Board, National Bank of Slovakia

Lubos Pastor is Charles P. McQuaid Professor of Finance at the University of Chicago Booth School of Business. At Chicago Booth, he also serves as co-director of the Fama-Miller Center for Research in Finance and a member of the CRSP Indexes Advisory Council. Outside Chicago Booth, he is a member of the Bank Board of the National Bank of Slovakia, Director of the American Finance Association, Research Associate at the National Bureau of Economic Research, and Research Fellow at the Centre for Economic Policy and Research. He has served as President of the Western Finance Association. Pastor's research focuses mostly on financial markets and asset management. His articles have appeared in the *American Economic Review*, *Journal of Finance*, *Journal of Financial Economics*, *Journal of Monetary Economics*, *Journal of Political Economy*, *Review of Financial Studies*, and other outlets. His research has been awarded numerous prizes. Pastor has a Ph.D. from the Wharton School at the University of Pennsylvania and Mgr. from Comenius University in Bratislava.
