Position of the committee with in CFAVBA

The active investing committee is a part of the CFA Society VBA Netherlands (hereafter named: CFAVBA). All its members are investing- or investing-related professionals who have earned the CFA- or RBA accreditation. Exceptions can be made by the board of the CFAVBA.

Committee Focus

The main focus of the committee will be active investing. Active investing can be interpreted in many ways, but primarily the committee will focus on the craft of active stock selection. The scope may amongst others contain: fundamental bottom-up, quant, long-term investing, active share/concentrated portfolios, artificial intelligence, position sizing and sustainability.

Committee purpose

- 1. The main purpose of the committee is the sharing of knowledge regarding active stock selection. This will mainly be in the form of presentations about investment processes, stock pitches and sharing new academic research.
- 2. Beside the main purpose, in the case of willing volunteers, there is room for members to focus on organizing an active investing conference (staff of CFAVBA will help) or to publish writing in the VBA Journaal.
- 3. Also, when called upon, the committee can give its views to relevant bodies regarding sector bestpractices.

Way of working

- Frequency once every 6 weeks
- Time 16h Tuesdays and/or Thursdays
- Location alternate Amsterdam, Rotterdam, The Hague and conference calls
- Size committee up to 20 members
