Meeting called to order: 12:10PM

Meeting Minutes

The July planning meeting minutes were presented for approval. Teresa Cutter motioned for approval, seconded by Hao Lin and the minutes were approved by the board.

President’s Report

Teresa Cutter notified the board of the upcoming CFAI Leadership Conference in Washington, DC.

Charter Award Dinner

Ms. Cutter provided the board with an update on Arden Hills Resort Club & Spa and The Vizcaya as possible locations for the Charter Award Dinner. Ms. Cutter stated possible dates for the event would be December 4, 5 or 12. She summarized the potential costs for each of the venues.

Ms. Cutter spoke of potential speakers for the dinner. The board discussed suggestions of speakers.

Action Item: Brian Leu to contact Java City founder to set a call to discuss possibly speaking at dinner.

Market Forecast Dinner (MFD)

Ms. Cutter distributed a list of potential speakers for the January market forecast dinner. The board discussed all the speakers listed.

Mr. Lederer stated that there is \$19,000 in the account with an outstanding account receivable of \$2,000 from Morgan Stanley.

Programs

Jane Delfendahl summarized the upcoming events for August and September.

The board discussed speakers for upcoming monthly luncheons.

Technology

Dave Murphy stated that there will be a conference call at CFAI to see a demo of CFAI online event registration system.

Mr. Murphy also stated that he is looking at CFAI's storage system of files.

Charitable Outreach

Denver Travis presented two possible charitable recipients to pass on proceeds or volunteering for: WEAVE or Women's Empowerment.

Dr. Travis suggested a fundraiser with sponsorships at a challenge course at Sacramento State. Proceeds to benefit a charitable organization.

Investment Research Challenge

There was certainly a shocker of an announcement—Jeff Diermeier, the president and CEO of CFAI, has resigned—see the CFAI website for details. Also, the head of PR has also resigned.

About half of the call was focused on the Investment Research Challenge (IRC)—Rhonda Reid, the global head of the initiative, explained how it works and the timeline—the local challenges need to be completed by 2/21/09. She also encouraged any Western Region societies who are interested in holding a challenge to contact her as soon as possible. Sacramento and Orange County expressed an interest in working with other Western Region societies to hold a regional IRC. Other societies are considering it and will contact Rhonda with questions and/or commitments. Rhonda will host a kick-off call if enough societies are interested.

The board will need to vote next month to determine if they will go forward to do an Investment Research Challenge.
