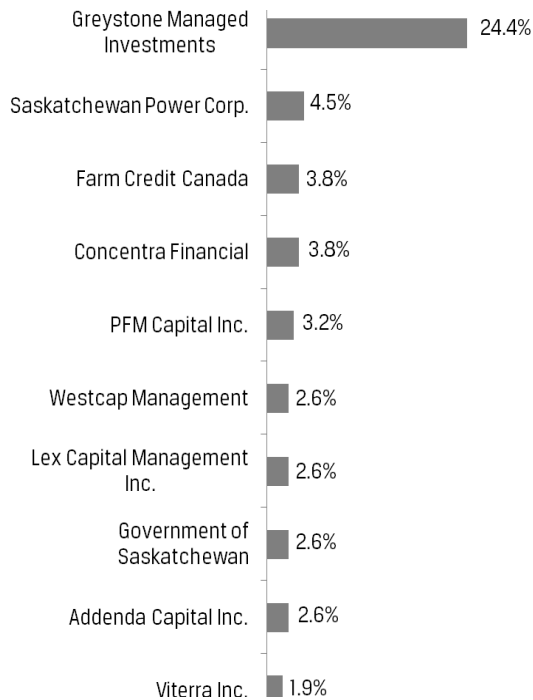

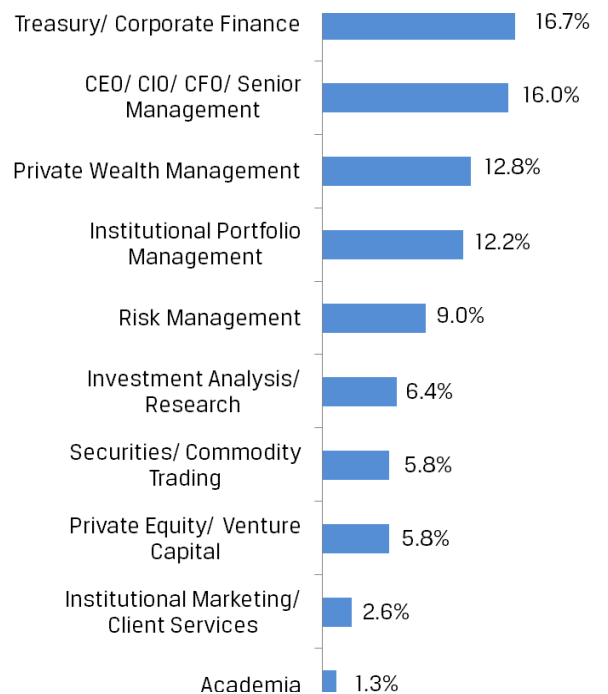

MEMBERSHIP REQUIREMENTS

Regular Member

To become a Regular Member of the Society, an individual shall be a Regular Member of CFA Institute and shall fulfill the education & work experience requirements of the Institute and such other requirements as the Society may impose. This membership type is recommended for candidates in the CFA Program and required for award of the CFA charter.

Local / Affiliate Member

To become an Affiliate Member of the Society, an individual shall be an Affiliate Member of the CFA Institute. This membership type is recommended for investment professionals who do not intend to participate in the CFA Program. Affiliate members receive the same benefits as regular members; however, affiliate members are not eligible for award of the CFA charter and may not vote on CFA Institute proxies.
