What Are the Events Conducted by CFACC?

Study Tips Session

A learning session where insights and tips on how best to approach the CFA exam will be shared navigating through the CFA curriculum to improve exam success. Two study tips sessions are planned to target the December & June exam cycle.

Calculator Masterclass

A specialized learning session dedicated to using the calculator in an effective manner to improve exam success. An experienced charterholder will take you through some of basic as well as advanced functions of the CFA approved calculator. Two such sessions are planned targeting the December & June exam cycle.

Practice Mock Exam

The mock exam gives Candidates the chance to practice facing a CFA exam under simulated exam conditions. The mock exams will be set by a globally recognized approved Prep Provider of the CFA Program and participants will receive a detailed answer guide. Two such exams would be held targeting the December & June exam cycle.

What Are the Events Conducted by CFACC?

Exam focus Masterclass

An experienced charterholder or a panel of charterholders will conduct a masterclass on specially chosen topics of the CFA curriculum based on feedback from candidates. At least two such tutorials will be conducted per exam session each one focusing on a particular level of the exam.
